

PET LICENSE APPLICATION

In Orange County, all dogs over the age of four (4) months are required by law to be licensed and vaccinated against rabies. Residents owning or having custody of any dog must license the dog within 15 days of acquisition or within 15 days after the license becomes due. Residents must provide proof of a California approved rabies vaccination to obtain a license (OCCO 4-1-70). **Failure to comply with the above time frames will result in a late fee of \$41.00.**
